

#### Increasing fiscal space for health

Many countries face increasing budgetary pressures to deliver the UHC ideal. There are four main ways to increase funding for health - borrowing more funds, increasing the share of government spending, increasing funds from development assistance, and improving efficiency of expenditure. We use a customised shape of the fiscal space diamond, supported by a bespoke and customizable modelling framework, to analyse the available budgetary room by mapping and reflecting the current and projected sources of revenue. We frame the analytical findings in a multi-stakeholder dialogue to identify the most appropriate avenues to make more resources available for investing in health.

#### Improving health sector efficiency

For many countries, a combination of ambitious health coverage targets, an increase of both communicable and non-communicable diseases, and (in some instances) a reduction in global support towards the health sector has enhanced the need to improve value for money in the health sector. We work with governments and ministries of health to identify and prioritise inefficiency areas, mobilise key stakeholders, and devise and implement actionable strategies for improving health spending performance. We are careful to situate spending efficiency within the realistically available resource envelope to increase service coverage, improve health outcomes, and advance financial protection.
