Health systems governance and service delivery

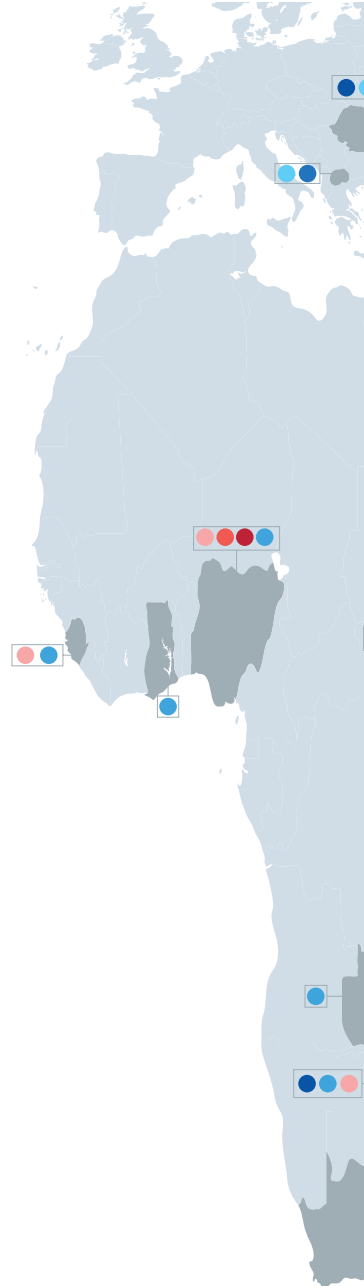

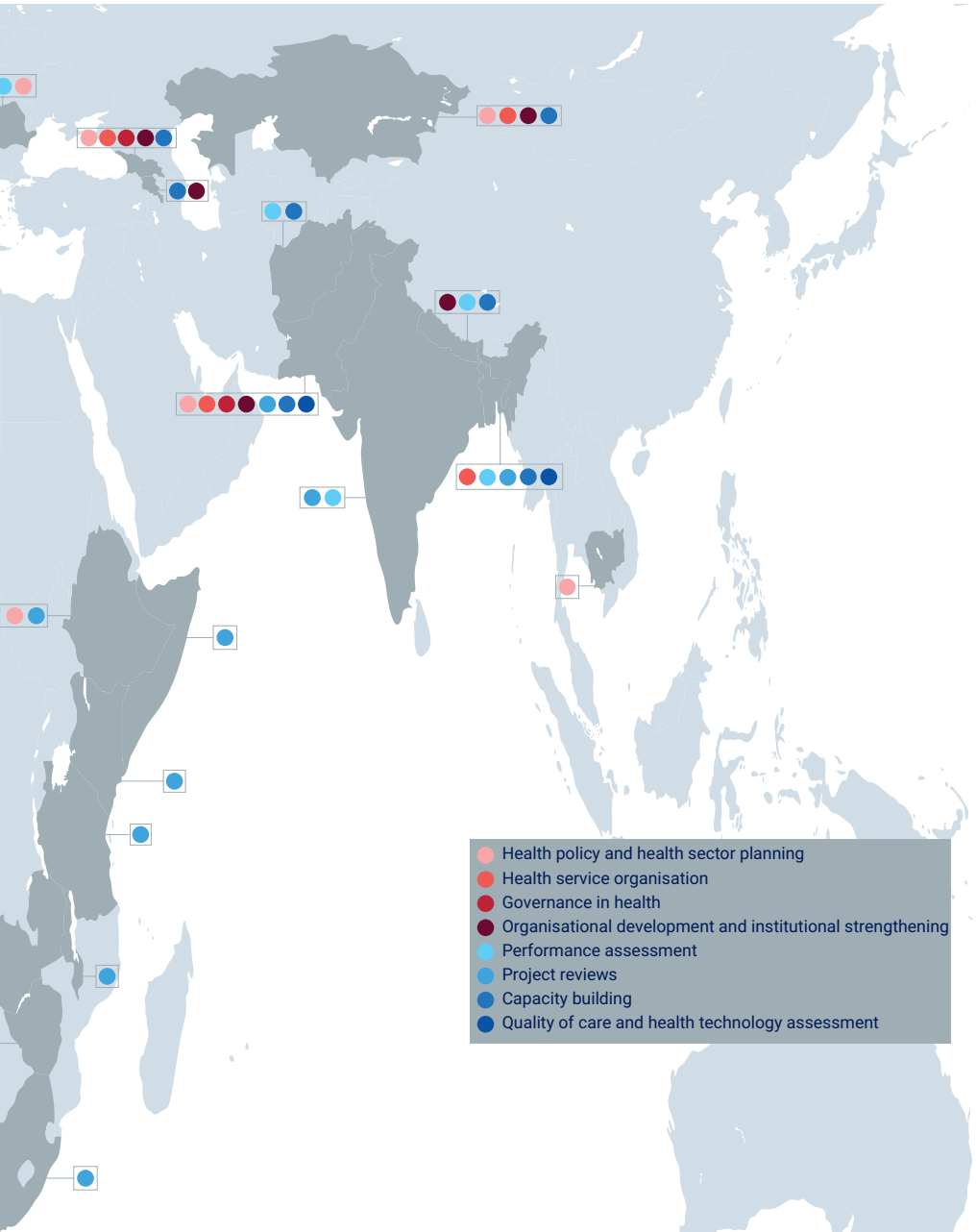

Delivering impactful results

HEART framework

2012–2016: Supported by the UK Department for International Development (DFID)

We led the **Health and Education Advice and Resource Team (HEART)** consortium, which offered knowledge services and call-down consulting in multiple countries. We implemented short-term projects in health, nutrition, and education, while also providing a dedicated website, topic packs, training, professional development sessions, and a variety of other resources.

During four years, HEART provided over 300 call-down services. Selected projects included:

- **Nepal:** reviewing the DFID health programme
- **Multi-country:** reviewing the Evidence for Action to Reduce Maternal and Neonatal Mortality in Africa project
- **Pakistan:** delivering reproductive health results through non-state providers
- **Kenya:** annual review of the Kenya Health Programme

- **Ghana:** designing support to the health sector
- **Nigeria:** strengthening the third phase of the Girls' Education Project
- **Zambia:** auditing equipment for the Emergency Obstetrics and Neonatal Care Project
- **South Africa:** analysing the political economy of the pharmaceutical industry
- **Pakistan:** verifying monitoring reports of the Delivering Reproductive Health Results project
- **Zimbabwe:** reviewing DFID Zimbabwe's Maternal, Newborn and Child Health Programme
- **India:** Primary healthcare, Tamil Nadu Health
- **Somalia:** conducting a technical review of maternal mortality research
- **Eastern and southern Africa:** reviewing the Preventing Maternal Deaths in Eastern and Southern Africa programme

Supporting primary healthcare in Georgia 2003–2008: Supported by DFID

We supported the development of the primary healthcare system in Georgia. The project covered six areas:

1. supporting structural reforms and improved public policy in the Ministry of Labour, Health and Social Affairs;
2. supporting strategy and capacity-building improvements in healthcare financing;
3. supporting development of the health management information system, with training for data managers, analysts, and users;
4. supporting human resource development through the development and delivery of health management training for 156 health system, primary healthcare, and hospital managers;

5. supporting more effective health promotion strategies; and
6. supporting the Minister of Health in improving public information and communication.

Social health protection in Bangladesh – steps toward universal health coverage

2014–2017: Supported by KfW

We are leading a consortium contracted by the Health Economics Unit of the Government of Bangladesh to assist the piloting of a health protection scheme, known locally as ‘Shastho Surokhsma Karmasuchi’. This pilot project is supporting more equitable and accessible health service delivery, increasing the treatment of insured diseases within the poor population of the pilot region.

Our team includes experts in the fields of public health, law, procurement, IT, communication, insurance economics, health economics, and infrastructure.

The technical support covers a wide range of areas, including:

- developing clinical guidelines;
- finalising accreditation standards;
- developing payment schemes;
- supporting the registration of participating households;
- implementing a fraud-proofing strategy;
- establishing financial management systems;
- carrying out training;
- introducing monitoring and evaluation systems;
- strengthening management capacities; and
- giving recommendations for future scale-up.



Monitoring, learning, and evaluation of the Bihar Technical Support Programme (BTSP)

2015–2017: Supported by the Bill and Melinda Gates Foundation

The BTSP supports the State Government of Bihar, India, in improving reproductive, maternal, newborn, and child health and nutrition outcomes. It is funded by the Bill and Melinda Gates Foundation and implemented by CARE.

OPM, in a consortium with Johns Hopkins University and the Liverpool School of Tropical Medicine, is undertaking an integrated approach to monitoring, learning, and evaluation of the BTSP.

The evaluation uses various different approaches to assess the extent to which BTSP activities have changed government attitudes and abilities, contributed to improved service quality, and led to improved health and nutrition outcomes.

Results-Based Financing Technical Assistance in Nigeria (RBFTA)

2014–2019: Supported by the World Bank

Since 2011 the Nigerian Government has been implementing the Nigeria State Health Investment Project in three states – Ondo, Nasarawa, and Adamawa. This results-based financing project strengthens service delivery at the health facility level, and institutional performance at federal, state, and local government area levels.

We were contracted by the National Primary Health Care Development Agency to lead a consortium that provides technical and management assistance to the

federal ministry and primary healthcare development agencies to implement RBFTA.

Currently, RBFTA contracts nearly 1,500 health facilities, with a combined catchment population of over 10 million people. After the first phases of implementation, RBFTA has exceeded expectations by dramatically increasing the coverage of results-based financing and driving significant improvements in service delivery quantity (particularly in vaccinated children, mothers seeking care, and outpatient treatment for malaria) and quality (particularly in care practices, drugs and supplies, and service availability). In recognition of this success, the Nigerian government has requested that we support the scale-up of results-based financing in five further states in northern Nigeria.

Assessing the performance of public hospitals with arrears in Romania

2016–2017: Supported by the World Bank

This project was undertaken using a three-pronged approach: examining general hospital performance, conducting a financial audit, and analysing the overall health sector context in relation to hospital organisation, governance, financing, and service purchasing.

The assessment informed the Government of Romania about challenges related to the accumulation of arrears in hospitals, but also about broader systemic and organisational issues calling for immediate reaction. It also suggested next steps in health sector development.
