Poverty and Social Protection

Our Poverty and Social Protection team assists governments and development partners in building inclusive, effective social protection systems that are sustainable and tailored to local contexts. We work closely with local, regional, and international organisations to share evidence on what works, helping to build consensus on the importance of social protection.

For the past 15 years, in partnership with the Government of Kenya and with FCDO support, we have generated evidence to strengthen social assistance programmes in Kenya. Through evaluations, studies, and technical assistance, our work has informed decisions on the design, targeting, and monitoring of Kenya's Hunger Safety Net Programme (HSNP) and the broader National Safety Net Programme (NSNP). Key factors in the programme's success include strong government champions, deep stakeholder engagement, and a trust-based partnership that has fostered efficient, sustainable, evidence-informed decision-making.

- 1. Evaluation of the Kenya Hunger Safety Net Programme (HSNP) 2008-2024:**

 - **Focus:** Monitoring, evaluation, and knowledge management for the Kenya Economic and Social Inclusion Programme (KSEIP).
 - **Impacts:** Studies ranging from large impact evaluations to smaller, targeted research have provided valuable evidence on the effectiveness and design of cash transfer programmes in Kenya. These evaluations and research have informed the following changes:
 - **Evidence as proof of concept:** from a pilot to a scalable programme: Impact evaluations demonstrated that cash transfers through the HSNP effectively reduced poverty and boosted local economies, providing key evidence that supported the Government's shift from food aid to cash transfers and the programme's scale-up and sustainability.
 - **Evidence for strengthening the programme design:** Pilot phase assessments and operational monitoring provided essential evidence to refine the HSNP's targeting approach, leading to a harmonised methodology that improved future programme phases and informed the design of Kenya's broader National Safety Net Programme.



- **Evidence for informing the effective implementation of cash transfers:** Operational monitoring during HSNP's second phase provided insights that led to improved coordination, communication, and a revised agency model for cash distribution, enhancing efficiency and accessibility for those receiving the transfers.
- **Evidence to inform policy direction and build global knowledge:** Our evaluations and studies on cash transfers and social protection in Kenya have significantly influenced policy discussions, leading to the evolution of Kenya's social protection policy from three to four pillars, and have also contributed to global public knowledge and academic curricula.

Governance
